The projected mill rate is \$ 7.84 per thousand, which may result in a levy increase of less than 3%. The tax levy is subject to change dependent on the following:

- Revenue limit recalculations based on actual enrollment
- Certification of equalization aid by DPI on October 15, 2014
- Certification of actual equalized value of the property in the District on October 15, 2014
